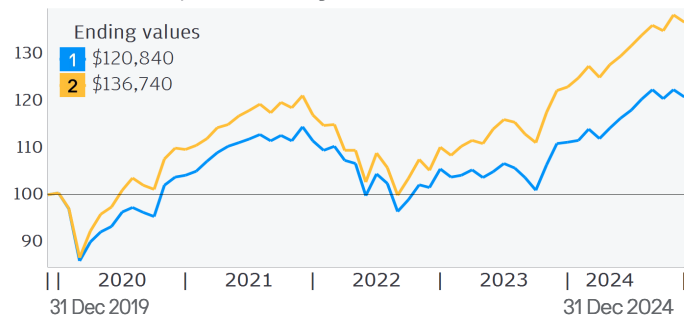

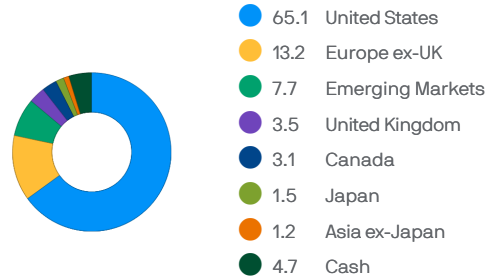

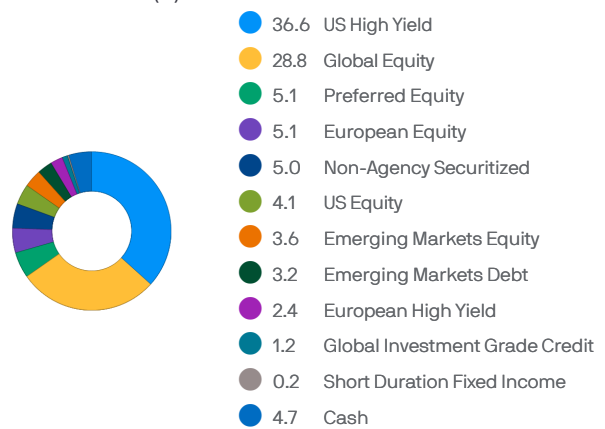

## Definitions
