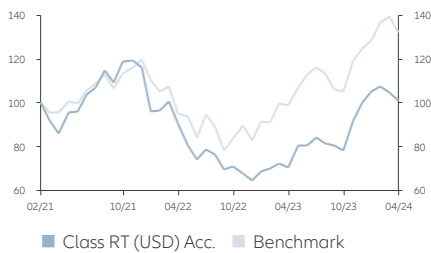

Indexed Performance since Inception (Bid-Bid)

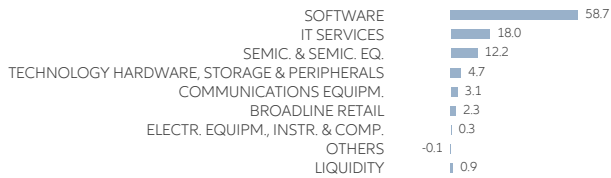

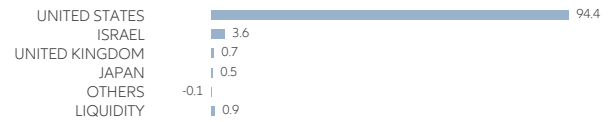
