

prefix, followed by nine further characters that are listed for each share class of the Sub-Fund. Cash & Equivalents are defined as the value of assets that can be converted into cash immediately. Volatility (Standard deviation) measures how widely individual performance returns, within a performance series, are dispersed from the average or mean value.
