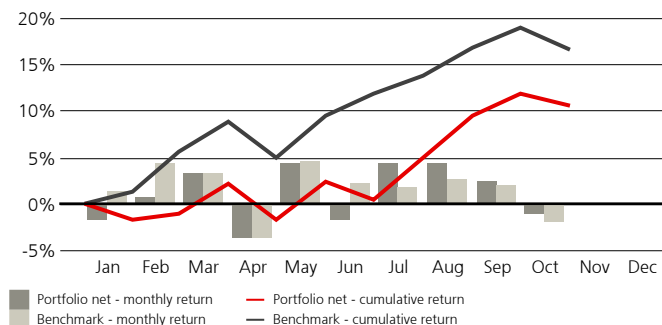

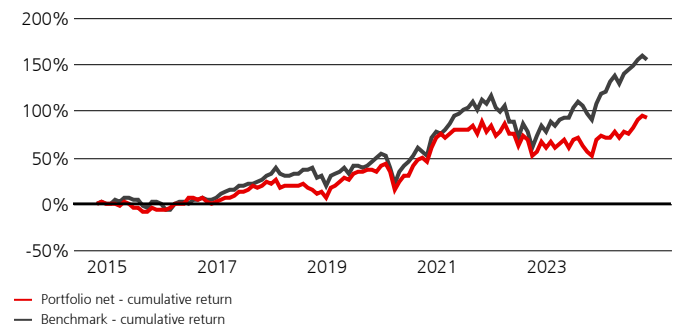
Performance overview - monthly & cumulative

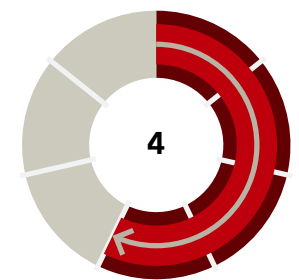

Performance commentary

The fund outperformed the broader equity market as measured by the MSCI World (NR) Index. In October, Entergy was the largest contributor, up +17%, as the utility company rose the lower end of its FY24 adjusted earnings per share (EPS) guidance and upgraded its FY26–28 adjusted EPS guidance by +4%, +6% and +9% versus the numbers provided during its latest analyst day. Entergy also increased its sales guidance mostly supported by higher demand from industrial companies (Entergy Q3 24 Earnings, 31.10.2024). Digital Realty was also among top contributors, up +10% over the month, as the company's Q3 24 results showed strong bookings stemming from 70% greater volumes and 30% higher prices (Digital Realty Q3 24 Earnings, 24.10.2024). In contrast, American Tower was among the largest detractors over the month, down -8%. Q3 24 was the first set of results after the India asset sale, which led to a lower guidance than consensus. The Tower company also disclosed a rise in net leverage versus Q2 24 (American Tower Q3 24 Earnings, 29.10.2024).

Market comments

Equities sold off after reaching the year-high in October following an increase in the US 10-year Treasury yield on strong employment data for September. As a result, Infrastructure stocks underperformed the broader equity market (source: Bloomberg, NMX Infrastructure Composite Index, MSCI World [NR] Index) during this period. Among the various sub-themes midstream, motorways and data centres performed best. Conversely, renewables, satellites and telecom towers were found at the bottom end of the ranking. Midstreams rose as beliefs of higher power for data centres would sustain gas volume for gas-fired electricity generation.

Comments on transactions

In October 2024, we trimmed positions across Canadian and US railroads, in French and Spanish toll roads Eiffage, Vinci and Ferroviol, respectively and fully sold the Portuguese utility EDP as the environment for companies with a large share of renewable assets and pipeline has deteriorated. During the month we increased our holding in data centre GDS and gas utilities NiSource and Sempra. The large demand of data centre capacity and the power sources required for them were the main considerations for the increase of our holdings in these stocks.

Top 10 positions - ESG Characteristics











Carbon emission intensity contribution by GICS sector







Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by GICS sector and are security weighted.
